Notable Political Law and Redistricting Matters

- Co-counsel to the National Republican Senatorial Committee and the Republican Governor's Association in litigation respecting Florida's system for organizing ballots in partisan elections, winning a complete victory on appeal at the United States Court of Appeals for the Eleventh Circuit. Played a significant role in drafting briefs before the trial court and the Court of Appeals. The Eleventh Circuit largely adopted the arguments on standing presented in the briefs, and the opinion by the

Eleventh Circuit has been cited in numerous other courts and briefs since it was issued in April 2020.

- Represented *amicus* non-partisan organization in briefing before the Texas Supreme Court on equal protection and related issues concerning the power of counties to change election procedures due to the COVID-19 pandemic in contravention of Texas State law.
- Co-counsel to certain members of both the Michigan House of Representatives and Michigan Republican congressional delegation in redistricting litigation, successfully appealing a three-judge panel opinion of the Eastern District of Michigan to the Supreme Court of the United States.
